On May 8, 2008 CWEA will host a one-day Specialty Conference titled Security and Disaster Preparedness with the core focus of assisting executive management in the Municipal Utilities sector with the development and implementation of crisis management, strategic turnaround, and growth management strategies. Speakers include: **Don Boland** the Executive Director of the **California Utilities Emergency Association**; **Rick Jones**, President and CEO of **InfraGard** Los Angeles; Special Agent **Regina Canale-Miles**, **Federal Bureau of Investigation** (FBI) Coordinator; **Ed Sullivan**, Business Continuity and Emergency Preparedness Coordinator for **East Bay Municipal Utility District** (EBMUD); **Charlie Howell**, **Security Concepts and Planning** CEO.

The continued operation of an organization depends on management's awareness of the potential impact of natural or man-caused disasters, its ability to develop a plan to minimize disruptions of critical business functions, and the capacity to implement that plan to recover business operations efficiently and in priority order. A business continuity program is an ongoing process to ensure that the necessary steps are taken to identify the impact of potential losses, maintain viable recovery strategies, recovery plans, and continuity of critical services.

The featured speakers will explain the key components of a comprehensive Business Continuity Program Plan (BCPs) and review strategies to assess BCPs for consistency, completeness, and potential conflicts. Case studies will be presented to illustrate the development of recommendations and to ensure the plans meet the agencies needs for business continuity and recovery in conjunction with the agencies Emergency Operations Plan.

The featured speakers will discuss recommendations with respect to relevant policies and procedures, information systems, alternate work locations, and vulnerabilities in several key business functions such as revenue collection. LACSD's Clearwater Program:

LACSD's Search for Innovative, Cost-Effective Strategies to Meet Future Needs

The Los Angeles County Sanitation Districts (Districts) are in the early stages of one of the most significant wastewater facilities planning and engineering efforts in their 80-year history. Entitled the "Clearwater Program," this effort will include the development of a master facilities plan that will focus on the Joint Outfall System (JOS), the Districts' network of treatment plants and sewers that is projected to serve 6.7 million people by 2050. This plan will provide adequate capacity for a growing population, evaluate opportunities for increased reclaimed water reuse and ensure the JOS remains protective of public health and the environment.

The plan will also evaluate the Districts' aging infrastructure, most importantly, the tunnels and ocean outfalls that convey effluent from the Joint Water Pollution Control Plant in Carson to the Pacific Ocean, and the potential need to construct a new \$1-2 billion discharge system. The two existing effluent tunnels were built in 1937 and 1958, flow full each day, and have not been inspected in nearly 50 years. Joe Houghton and David Haug will provide an overview of the Districts' facilities planning and preliminary engineering efforts for this ambitious program.
